

## **TERMS OF THE COMPETITION**

**Selangor Crown Prince Golf Charity Cup 2024** is a tournament played over 18 holes played at Tropicana Golf & Country Resort. The maximum number of players is 132.

### **1. MANAGEMENT**

**SAY Selangor Crown Prince Golf Charity Cup 2024** (hereinafter referred to as the Tournament) with SAY (hereinafter referred to as the Event Organizer).

The Tournament is managed by EO and appointing a Tournament Committee (hereinafter referred to as the Committee) whose decisions in all matters pertaining to the Tournament shall be final.

### **2. VENUES AND DATES**

30<sup>TH</sup> November 2024 @ Tropicana Golf & Country Resort

### **3. FORMAT OF PLAY**

As this event is geared to Charity & Networking, the organizing committee has decided to play **Stableford System 36** which allows same-day handicapping system. This allows golfers who don't have official handicap indexes to play in tournaments that require the use of net scores.

### **4. MAXIMUM SCORES (Rule 21.2)**

The maximum score that a player can post on any hole during the tournament is par +3. In other words, if you are three over par on any hole, you should pick up the ball and write the maximum score as shown and move on to the next hole

In the event on players withdrawal during a round, a maximum score will be imposed on their remaining holes.

### **5. TEEING AREAS**

Men shall play from the BLUE teeing areas. Ladies shall play from the RED teeing areas.

### **6. CADDIES**

CADDIES shall be provided by EO . No personal caddies allowed.

### **7. ELIGIBILITY**

The tournament is opened to all Male and Female Malaysian / Non Malaysian amateur golfers.

## **8. ENTRIES, WITHDRAWALS, TRANSFER & CHANGE OF QUALIFYING ROUND**

All entries must be received two (2) weeks before event date or on first come basis.

There shall be no REFUNDS for withdrawal/cancellation. However can be transferred to another player by written notification to the EO no less than 7 days prior to the event and subject to agreement of the EO.

## **9. REGISTRATION**

All players are required to register in person 30 minutes before registration counter is closed. Failure to do so may result in the player being withdrawn from the Tournament with no refund of any fees paid.

## **10. RULES OF PLAY**

The Tournament shall be played in accordance to the Rules of Golf as approved by The R&A Rules Ltd, the Local Rules of the respective Tournament venue and any additional local rules set by the Committee.

Penalty for breach of Local Rule: 2 strokes, unless stated otherwise.

## **11. CONFORMING GOLF BALLS**

Any ball used in making a stroke must be on the current List of Conforming Golf Balls issued by The R&A.

Penalty For Making a Stroke with a Ball Not on Current List in Breach of this Local Rule: Disqualification.

## **12. DRAW AND STARTING TIME**

Players shall be arranged in groups of a maximum of four (4) players.

The Committee shall prepare the draw.

The Tournament will be a shotgun start. All players are to station themselves at their respective tee boxes 10min prior to the tee-off time.

The Committee reserves the right to change the draws and vary the starting times as it deems fit.

If the player arrives at his starting point, ready to play, within five minutes after his starting time, the penalty for failure to start on time is two strokes in stroke play. Otherwise, the penalty for breach of this Rule is disqualification.

## **13. PACE OF PLAY POLICIES**

The attention of the competitors is drawn to Rule 5.6 regarding undue delay. The Committee will not hesitate to impose the penalties as provided by that Rule. The pace of play policy is displayed at the notice board.

#### **14. RULINGS BY COMMITTEE**

A referee's ruling on the facts or how the Rules apply must be followed by the player.  
The Committee's ruling is final

#### **15. DECISION ON TIES**

In the event of a tie in scores, it shall be decided by a count-back system in the following order:-

- a. lower handicap takes precedence (ie. lower handicapper wins), or
- b. last 18 holes of final round (holes 1 to 18), or
- c. last 9 holes of final round (holes 10 to 18), or
- d. last 6 holes of final round (holes 13 to 18), or
- e. last 3 holes of final round (holes 16 to 18), or
- f. last hole of final round (hole 18).

#### **16. CODE OF CONDUCT**

All players should practice good conduct as detailed in Rules 1.2a. Following may be considered a breach of code of conduct:

#### **17. SCORECARDS**

Scorecards must be promptly returned and, in any case, not later than 15 minutes after completion of the round.

BOTH the player and the marker must be present together when submitting their scorecards. Otherwise, BOTH their scorecards will not be accepted.

A scorecard is deemed submitted the moment it has been accepted by the official scorer.

#### **18. DISPUTES AND DECISIONS**

If a player believes another player's actions are not in accordance with the Rules of Golf, he or she must immediately bring it to the attention of the player concerned.

In the absence of a referee, if a player is uncertain about the right procedure while playing a hole, he or she may complete the hole with two balls without penalties, as per Rule 20.1c(3). When a player has played two balls, he/she **must report** the fact of the situation to the Committee before returning the scorecard, even if the player scores the same with two balls. **The player is disqualified if he or she fails to do so.**

All rules questions and/or disputes, if any, must be reported to the Committee prior to all players leaving the scoring area.

A marker would be disqualified if he or she knowingly certifies a wrong score for another player, as per interpretation 3.3b(1)/1.

#### **19. COMPETITION CLOSED**

The Tournament shall be deemed closed when the prizes/trophy have been awarded to the winners.

## **20. INCLEMENT WEATHER AND SUSPENSION OF PLAY**

The Committee will make every effort to complete an event in it's entirely. However, the Committee reserves the right to suspend or abandon play as deemed necessary.

In the unlikely event if the course is unplayable and play is abandoned or other conditions warrant such action, the Committee shall then decide either to continue play the following day or to take whatever course of action.

## **21. INDEMNITY / LIABILITIES**

The Sponsors, The Organizers, The Committee or the management of respective golf clubs will not be responsible for any loss or damage or harm, or any form of injuries that the participants of the event may suffer as a result of their participation in this tournament and for any postponement or cancellation of the tournament.

## **22. ACKNOWLEDGEMENT & CONSENT**

By communicating with Scene Global Ventures services, or by virtue of your engagement is with SAY that you acknowledge that you have read and understood this Private Policy and agree and consent to the use, processing and transfer of your Personal Data by SAY as described in this Private Policy.

By signing the entry form, participant agrees to be filmed, photographed, televised or otherwise recorded during the Tournament, and that captured or recorded image, together with the name, may be used in any Content, format and through any media or technology whether now existing or created in the future, by the organizing committee, and third parties authorized by the organizing committee during or after the Tournament, in perpetuity in relation to the celebration and promotion of the game of golf in a non- commercial manner.

## **24. AMENDMENTS**

All the above is subject to change at the discretion of the Tournament Organizing Committee whose decision in all matters is final.

## **TOURNAMENT ORGANIZING COMMITTEE**

Selangor Crown Prince Golf Charity Cup 2024 is managed by SAY and whose decision in all matters shall be final.

The Tournament Organizing Committee reserves the right to exclude any player from the Tournament at its discretion.

The tournament rules committee shall be responsible for running the tournament in accordance with Rules of Golf as approved by the R&A Rules Ltd, Terms of the Competition and the Local Rules of the respective Tournament venue.

The Tournament Organizing Committee reserves the right to accept, refuse or withdraw any entry if found to be questionable.

All the above is subject to change at the discretion of Tournament Organizing Committee who's the decision in all matters is final.
